



Privacy Policy

MFE Pty Ltd ABN 90 152 922 926 handles personal information in accordance with the *Privacy Act 1988*, the Australian Privacy Principles and its Privacy Policy set out below.

This Privacy Policy tells you how we collect, store, use and disclose personal information.

THE INFORMATION WE COLLECT

The types of personal information we collect includes:

- names;
- information about your identify;
- job descriptions and occupations;
- addresses;
- contact numbers;
- suppliers you have, or previously had, a business relationship with;
- credit information (for example, your ability to repay your debts); and
- credit eligibility information,

and any other type of personal information you voluntarily give us.

We do not collect sensitive information.

WHEN WE COLLECT INFORMATION

We collect personal information:

- when you contact us in person, over the phone, through our website or by email;
- when you place an order by completing an order form or issuing us a purchase order;
- when you apply for one of our 30 day credit accounts;
- when you personally guarantee the performance of one of our company customers; and
- when we make enquiries with your trade references.

WHY WE COLLECT INFORMATION

We collect, hold, use and disclose personal information for these reasons:

- to identify you
- to perform services or supply you with goods
- to issue you a proper tax invoice
- to collect any money you owe us
- for legal compliance;
- to perform credit checks on you.

If permitted under the *Privacy Act 1988* (Cth), we may disclose credit information or credit eligibility information about you to any of your suppliers or clients that make enquiries about your credit account with us.

HOW WE STORE INFORMATION

The personal information we collect is stored securely on our premises or on our electronic servers.

We only grant access to your personal information to certain personnel who require it to deliver our services to you.

WHEN WE USE AND DISCLOSE INFORMATION

We use and disclose personal information to third parties outside MFE when we -

- perform services or supply goods to you;
- engage professional services for professional advice (for example, lawyers, accountants, insurance brokers and auditors)
- engage in debt recovery;
- communicate with your suppliers (when you nominate us as a trade reference);
- perform a credit check on you (when we contact your nominated trade references); and
- are compelled to do so by law.

USAGE FOR MARKETING

We may use your personal information to sell you services that we think may be of interest to you. This may include by sending you a newsletter or an update about our business.

ACCESSING YOUR INFORMATION

You may contact in writing and ask what information we hold about you.

We reserve the right to refuse you access to your information if:

- you refuse to verify your identity;
- you refuse to pay a reasonable administration fee to us for processing your request;
- the request could infringe someone else's privacy; or
- there are related legal proceedings or matters underway.

OUR WEBSITE

We may use cookies on our website to collect and store personal information about you.

You can disable cookies through the cookie settings from within your internet browser.

Our website may also collect Internet Protocol (IP) addresses. This is a unique address that allows us to identify your computer within a global network.

UPDATES TO OUR PRIVACY POLICY
